- managing the generated waste and other environmental applicable aspects and maintaining the safety of work in accordance with the relevant requirements of legal and health and safety regulations and environmental protection, and where it is technically and economically possible to exceed these requirements,
- employee training and increasing the level of awareness and sense of responsibility for performing work in order to shape behaviors that reduce the risk of human and environmental hazards,
- prevention of injuries and occupational diseases, and continuous improvement of health and safety,
- ensuring greater energy efficiency in buildings,
- investing in environmentally friendly technologies, such as renewable energy sources,
- implementing measures to reduce greenhouse gas emissions,
- promoting environmental and Safety Policy in the company and at clients, suppliers and subcontractors.
